The College will provide student schedules to the appropriate Private School personnel at the end of the Drop period each term upon the Private School's request to the Dual Enrollment Coordinator on the Lakeland or Winter Haven campus.

**Tuition and Fees: Addendum to "A Funding Provision That Delineates Costs Incurred by Each Entity"**

The College will not assess tuition and fees to a Private School or their students. Students are responsible for transportation, textbooks, and supplies.


