Students will be evaluated through cognitive testing practical exercises that will demonstrate their proficiency. Topics of instruction include: Training Liability and Ethics, Adult Learning Theory, Principles of Instruction, Performance Objectives, Evaluation Methods, Measurement and Testing, Lesson Plan Preparation, Instructional Strategies / Methods / Techniques, Learning Aids, Using a Prepared Lesson Plan Prevident Strategies, and Human Diversity.					
	Students are encouraged to bring a laptop computer to class to work on presentation projects. Students must also be knowledgeable in the use of PowerPoint presentation software.
