**Approval of January Minutes**. Amy moved to approve the January minutes. Johnny seconded the motion. The motion carried.

## **Reports**

*President's Report* Bill updated the Senate on enrollment. As of February 5, FTE (full-time equivalent) enrollment is up 2.3% compared to last spring.

Bill uploaded "What's New—What's Up" to the Senate PIE page. This document summarizes all significant recent and current activity in each area of the College.

Though it is still early in the annual legislative process, there does not seem to be any interest in permitting a tuition increase. The Governor has released a budget that would double the "college investment portion" of performance funding from \$30,000,000 to \$60,000,000. This is the portion of the base budget of each college that is "at risk" pending performance ranking. But the governor's budget rarely survives the legislative process without significant changes.

There is an Adjunct Faculty Meeting on Saturday, March 2 at 9 a.m. at the Center for Public Safety. Breakfast will be provided and Dr. Falconetti will have an open discussion/dialogue centered on adjunct needs.

### Lakeland Vice President's Report

Cindy noted that schedule building for the 2020 academic year is in progress. Administrative assistants are finalizing the schedule input, and schedule proofing will begin soon. The full 2019/2020 schedule is set to go live to the public on March 18, 2019.

The QEP Selection Committee has had two meetings so far this term. The list of nine broad areas of consideration from last semester's committee work has been narrowed to two. Surveys from Polk State employees and students and a survey of employers helped to narrow the list. The two broad topic areas are "Career Planning and Readiness" and "Getting on and Staying on a Path." The next meeting is scheduled for Friday February 15. Final Topic Selection is anticipated for March 2019.

Dr. Falconetti, Steve Hull, and Tamara Sakagawa met with Lakeland program directors and departmental coordinators on January 30 to discuss the current status of SEIU's efforts to unionize Polk State College adjunct faculty. The purpose of the meeting was to inform DCs and program directors about the unionization process and to provide tools that can be used to share information with and respond to questions from our adjuncts.

The College is making plans right now to expand apprenticeships and start new programs in order to get some of the new funding.

Steve stated that the Governor has taken on an ambitious agenda as it pertains to education and the College needs to see how that gets operationalized.

Misty stated that the C.O.L. P.E. Instructor hiring committee has sent two names forward.

Andrew stated that the opening reception for "One Billion Rising" is February 12 from 5 p.m. to 7 p.m. in the Winter Haven Art Gallery.

Lorrie announced that the hiring committee for two new nurses will be meeting as soon as the applicants have been vetted by HR.

### **Old Business**:

Senate Constitution Faculty-wide Vote. The Constitution demands a secret ballot to vote on the proposed amendments to the Constitution. Steve spoke with Nathan Neuman and determined that there is a mechanism that can be used to do this electronically. The next step will be to confirm the accuracy of the faculty-wide mailing lists. Bill will send out the information he has to allow

each senator to confirm that each department list is accurate. Once the Senate has confirmation of an accurate mailing list, Microsoft Forms (which is in PIE) will be used as the mechanism to allow all full-time faculty to vote. Nathan will work with the Senate to make ensure that the ballot is worded properly before he sends it out.

## **Business from the Floor:**

Bill stated that there is a new page on PIE called The President's Corner. This is from President's Staff. It has messages from Dr. Falconetti, links to the College's social media feeds, the President's Staff meeting agenda, and President's Staff meeting minutes. It also has all of the College's rules and procedures.

Rebecka shared a question posed by a constituent: Why are online classes still classified by campus? Bill answered that this question has come up before. The courses have to be tied to a campus because they are taught by faculty. Another reason for this is the need to provide textbooks to the appropriate bookstore(s). Additionally, the need for proctored testing necessitates the need to tie the course to a particular campus's TLCC. The courses are listed alphabetically by campus because of the system Genesis uses. Steve stated that with the switch to Jenzabar, the alphabetical listing will change. The way that students search and the way that open courses come up will also change with Jenzobar. As to when the full switch to Jenzobar will occur, Steve stated that he would seek more information to return to Senate with.

Misty expressed a concern about the security of the Winter Haven library. The doors do not lock from the inside. Steve stated that he would look into this immediately.

Amy expressed a concern about a student with limited mobility because of spina bifida who attends the College and is having difficulty finding transportation to campus. Steve stated that he would contact Amy and seek a resolution.
