Construction Management at Risk Services Building #3 Winter Haven Science Building (WSC) Wintr Haven Campus

1. Background

- a. Polk State College issued the Request for Qualification (RFQ) #22-07 for Construction Management at Risk Services in accordance with the requirements of the Purchasing Manual. The purpose of the public solicitation is to select a firm to provide Construction Management at Risk services as described in the Scope of Work, associated drawings and specifications for the remodeling and renovation of a 2-story building.
- b. Generally, the services include:
 - i. Preparation of a Guaranteed Maximum Price (GMP).
 - ii. Code compliant Construction Management Services.
 - iii. Implement energy conservation means and methods to assist in resource conservation and the expense of operation.
 - iv. Support the College's Direct Material Purchase Program.
 - v. Coordinate with Polk State College staff and A/E firm selected in the companion RFQ #22-06

- c. Posted on the Polk State College website at the Procurement Department's web page RFQ #22-07.

3. Distribution / Submittals

- a. The RFQ document was available for download from the Polk State College Purchasing website.
- b. A non-mandatory Pre-Proposal conference was held on April 13, 2023.
- c. Seven (7) proposals were received. ALL seven (7) proposals were reviewed and deemed to be responsive and accepted. In alphabetical order:

- d. The voting member of the Evaluation Team met May 11, 2023. At which time, the proposal were reviewed and scored pursuant to the guidelines outlined in the RFQ document.
