Spring Course Updates

Contact Mrs. Edgecomb if you would like to DROP a 16-week or Fast Track 1 course (without penalty) by Tuesday, January 12 at 4pm. Requests made after the DROP deadline will now become a course WITHDRAW and posted to transcripts. Students cannot ADD, DROP or WITHDRAW from a course via PASSPORT, as such features are blocked for all high school students. Contact Mrs. Edgecomb for schedule changes before the academic term deadlines. CHS students must be enrolled in a minimum of four courses per fall and spring term.
