TESTING

All applicants must take the **Basic Abilities Test (BAT)**, as mandated by 943.17(1)(g) FSS. The registration fee is **NON-REFUNDABLE**. To pay and register for the test go to: <u>https://home.pearsonvue.com/fdle/bat</u>

NOTE: You must pass the Basic Abilities Test in order for the application process to continue.

Polygraph Examination: The applicant will be responsible for scheduling their polygraph exam, with an IPS approved polygraphist upon completion of a pre-screening application. **\$150 NON-REFUNDABLE.**

PHYSICAL EXAMINATION

A complete physical examination, including an EKG, is required of each applicant and must be done, by an approved licensed physician. A 7-panel drug screen is also required. The forms supplied by IPS <u>must be utilized</u>. The results of the examinations and the drug screen must be submitted to the IPS along with the application. **\$125**
