### Polk State College District Board of Trustees Considering Changes in Fees for 2019-20

Winter Haven, May 22, 2019 - The Polk State College District Board of Trustees (DBOT) will consider changes in lab fees for college credit and Educator Preparation Institute courses offered at the College at the June 24, 2019 Board Meeting. Each year the College evaluates all fees to ensure that charges accurately reflect any changes in the cost of instructional materials or supplemental items required for courses. Polk State has a total of 216 lab fees for the 2019-2020 Academic Year. with 208 unchanged from 2018-2019. Four lab fees are decreasing due to the removal of the courses from the College catalog. Four fees are being added to serve new courses. Details of the fee changes are described below:
