GETTING STARTED

The first step to admission is to complete an online application at **polk.edu/admission-aid**. Use the Admission Guide to Polk State College, which has details, a comprehensive checklist, and great FAQ section to help students complete all the admission requirements to the College.

Admission to the bachelor's degree program requires a previously earned Associate in Science or Associate in Arts degree, or the equivalent, from a regionally accredited institution, and at least a 2.0 grade-point average. Students who hold an Associate in Applied Science degree may need to complete additional general education courses prior to admission.

Prospective bachelor's degree students who already hold an AS should select the following program code in the online application: S6100 Criminal Justice from Earned AS. Those who hold an AA degree should select S6150 Criminal Justice from Earned AA. Students who hold both an AS and AA degree should select S6100.

All students must also submit their official transcripts to the College, including those from high schools, colleges and universities previously attended, as well as home school affidavits and documentation related to military service.

Upon acceptance to the College, bachelor's students must meet with the Bachelor of Science program specialist to determine a degree plan.

Polk State's Criminal Justice Program equips students with working knowledge of each facet of the criminal justice system — law enforcement, adjudication and corrections. WHY **POLK STATE?**


Throughout its 50-year history, Polk State College has been known for its integration with the local workforce, and nowhere is this more evident than in our Criminal Justice programs.

Polk State Criminal Justice includes the Associate in Science degree in Criminal Justice Technology and the Bachelor of Science in Criminal Justice. The College delivers these degree options through hybrid, online and accelerated formats to meet the needs of working students.



ASSOCIATE IN **SCIENCE**

The Associate in Science in Criminal Justice Technology is designed to prepare students with cross-functional skills necessary for entry-level positions in corrections, law enforcement, parole/probation, private/industry security and other areas of the criminal justice system.

The degree requires 64 credit hours. The curriculum focuses on organizations and administration within the criminal justice system, including the fields of corrections, criminal investigation, criminal law and juvenile justice.

This degree prepares students to work in law enforcement, corrections, probation/parole, private/industry security, and other criminal justice fields. It also provides an educational path for officers who have passed recognized certification examinations in law enforcement, corrections, and probation/parole. This degree is also beneficial to employees in law enforcement seeking incentive benefits or career enhancement.

BACHELOR OF **SCIENCE**

The Bachelor of Science in Criminal Justice degree provides students with a broad understanding of crime and society's crime-control mechanisms, preparing them for professional careers in criminal justice.

Students in this degree program receive a broad overview of the interdisciplinary field of criminal justice, including causes and prevention of criminal behavior, criminology, law, psychology, public policy, and sociology.

The degree requires 120 credit hours, 60 of which come from a previously earned Associate in Arts or Associate in Science degree. The curriculum includes content related to deviant behavior, criminal investigation, corrections, the court system, and criminal justice administration.

Graduates are prepared to begin careers in corrections, law enforcement, private/industry security, parole/probation and related fields. This degree is also beneficial to working law enforcement professionals who seek career advancement. Graduates of this program are prepared to pursue master's degrees in Criminal Justice or related fields.

Note: Regardless of any degree earned, in order to be a sworn law enforcement or corrections officer, students must successfully complete (1) a state-certified training academy such as Polk State College's Kenneth C. Thompson Institute of Public Safety and (2) pass the state examination. For more information on Polk State's internationally accredited public safety institute, visit **polk.edu/public-safety**.
