Website Design, Development, Hosting, and Maintenance

1. Background

- a. Polk State College issued the Request for proposal (RFP) #24-02 Website Development in accordance with Polk State College's Purchasing Manual. The purpose of the public solicitation is to select a firm for the design, development, hosting, and maintenance of a dynamic, information-rich website.
- b. Generally, the services include the following:
 - i. The development of a website that attracts, engages, and retains credit and non-credit students; markets the College's available programs and services; provides a simplified front-end enrollment and registration, including the cost, tuition, fees, and available tools for payment; and complies with all federal requirements for educational websites.
 - ii. Host the College's website in its entirety and invest in business continuity practices, including conducting and maintaining regular website back-ups, as well as redundant Internet connections, along with 24/7 technological support, to ensure the College's business continuity related to the website as part of an ongoing maintenance agreement.

- a. The RFP was advertised in the Polk County Democrat.
- b. The RFP was posted on the Polk State College website at the Procurement Department's web page RFP #24-02.

3. Distribution/ Submittals

- a. The RFP document was available for download from the Polk State College Procurement website.
- b. Seven (7) proposals were received. Six (6) proposals were determined to be responsive and accepted. One (1) proposal was determined to be unresponsive and not accepted.

- 5. Oral presentations/interviews were held on April 8, 2024. The Evaluation Committee scored each presentation as follows:
