# Architect/Engineering Services for WLR 3<sup>rd</sup> Floor Remodel/Renovation

## 1. Background

- a. Polk State College issued the RFQ #15-03 in accordance with Purchasing manual. The purpose of the public solicitation is to select a firm to provide Architectural and Engineering Services for the remodel/renovation of the WLR 3<sup>rd</sup> Floor.
- b. In general, the services include:
  - i. Providing support in the development of the Guaranteed Maximum Price (GMP)
  - ii. Architectural/ Engineering and ancillary services.
  - iii. Utilize Building Information Modeling (BIM) and 3-d modeling/presentation software
  - iv. Support the College's Direct Material Purchase Program.
  - v. Coordination with Polk State College staff and Construction Manager selected in the companion RFQ #15-04.

#### 2. Advertisement

- a. The RFQ was advertised in the Polk County Democrat
- b. Posted on the Purchasing Department's ITB/RFQ bulletin Board
- c. Posted on the Polk State College web-site at the Purchasing Department's web page RFQ #15-03.

#### 3. Distribution / Submittals

- a. The RFQ solicitation document was advertised May 15, 2015. Notification of the RFQ solicitation document availability was emailed to firms which had requested to be on our bidders list to provide this service.
- b. The RFQ document was available for download from the Polk State College Purchasing website.
- c. A mandatory Pre-Proposal conference was held on June 3, 2015
