4.01	Code of Conduct for Students and Student Organizations	March 25, 2024

#### I. Purpose

The purpose of this rule is to establish expectations related to the conduct, deportment, and integrity of all students participating in educational and extra-curricular experiences at Polk State College. It also outlines and defines unacceptable conduct, and identifies procedures (including disciplinary procedures) that apply to each type of infraction.

## II. Overview of Student Expectations

Polk State College students agree to act in a responsible manner in all areas of personal and social conduct, and to take full responsibility for their personal and collective actions. Learning can only take place in a setting that is free of intimidation and coercion. Students must observe local, state, and federal laws, as well as the academic and behavioral rules found within the *Polk State College Catalog/Student Handbook*, in other publications, and on the Polk State College website (polk.edu). Polk State College students are expected to:

- A. Be courteous to fellow students, faculty, personnel, and all those participating in College events and activities.
- B. Be punctual when attending classes and completing course assignments, as well as in following College instructions, rules, and procedures.
- C. Be fair and honest in all interactions with students, faculty members, and College personnel in communications, including e-mail and online class communications.

#### III. Definitions

- A. The term "College," when used as a noun or adjective, refers to Polk State College.
- B. The term "student" includes any person taking program courses (i.e., credit or non-credit) at the College, whether full-time or part-time, within face-to-face, hybrid, or online classes. This also includes any person taking classes or participating in College activities on and off campus. A person who is not officially enrolled for a particular term, but who has a continuing relationship with the College, is representing the College, or is interacting on behalf of the College with faculty, staff, and students, is also expected to adhere to this *Student Code of Conduct*.
- C. The term "College premises" means buildings or grounds owned, leased, operated, controlled, or supervised by the College, including online environments used by the College.
- D. The term "College-sponsored activity" means any activity on or off campus that is initiated, aided, authorized, or supervised by the College or any College organization.
- E. The term "College official" includes any person employed by the College who is performing assigned responsibilities.

- F. The term "plagiarism" is defined in Section VIII.A of this document. Academic dishonesty is also addressed in Polk State College Procedure 5026: *Academic Dishonesty Procedure*.
- G. The term "distribution" means sale or exchange for personal profit.
- H. The term "weapon" means any object or substance designed to inflict a wound, cause injury, or incapacitate, including, but not limited to, any firearm, pellet gun, paintball gun, knife, or simulated weapon.

## IV. Student Code of Conduct: Overview

The conduct listed in Section V through Section X of this document is unacceptable and subject to disciplinary action. A student may be held accountable to both civil authorities and to the College for acts that violate the law and this Rule. Polk State College Procedure 5028: *Student Code of Conduct: Sanctions and Assignment of Penalties for Violations* outlines the process for imposing sanctions for violations of this Rule.

College disciplinary actions normally proceed while criminal proceedings are pending; these are not subject to challenge on the grounds that criminal charges involving the same incident have been dismissed or reduced. The student has the right to appeal *Student Code of Conduct* violation charges. Polk State College Procedure 5025: *Student Hearing Appeals Protocol* outlines the appeal and hearing process.

This *Student Code of Conduct* applies to students as individuals, student groups, and organizations. An individual who has committed an infraction as part of a student group or organization may be held personally responsible for the group's behavior along with the group's leaders, officers, or spokespersons. Polk State College Procedure 5029: *Student Code of Conduct Violation Procedure: Student Groups and Organizations* addresses violations by groups and organizations.

Disruptive conduct is reported to the Dean of Student Services (or his or her designee) via the *Student Disruption/Discipline Report* available from Student Services.

#### V. General Violations of the Student Code of Conduct

In addition to the *Student Code of Conduct*, a student enrolled in online, hybrid, or face-to-face classes is advised to review each specific course syllabus for policies related to violations of the *Student Code of Conduct* in the classroom or online course environment.

Any student who is suspected of misconduct as listed in this document is subject to sanctions and provided due process as outlined in Polk State College Procedure 5028: Student Code of Conduct: Sanctions and Assignment of Penalties for Violations.

The following general classifications of misconduct (as well as those listed in Section V through Section X of this document) are specifically prohibited while on campus, within online course environments, and during all College-related functions:

## A. Abuse

Physical abuse, verbal abuse, threats, intimidation, harassment, coercion, and any other conduct that threatens or endangers the rights, health, or safety of any person are prohibited.

#### B. Bribery

This includes offering or giving money or any item of service to a Polk State College employee for the purpose of attempting to obtain assistance that would not have otherwise been provided.

## C. Bullying

Bullying includes any of the following behaviors directed at an individual or group:

- 1. Unwanted teasing
- 2. Threatening or intimidating behaviors
- 3. Stalking
- 4. Public humiliation
- 5. The spreading of malicious or derogatory rumors or falsehoods
- 6. The use of discriminatory slurs
- 7. Cyberbullying, including the use of technology (e.g., phone, email, instant messaging, text messaging, social media, or other means of communication) to engage in deliberate harassment or intimidation.

#### D. Discrimination

Any treatment or consideration of (or making a distinction in favor of or against) a person or thing based on the group, class, or category to which that person belongs (i.e., rather than on the individual's merit) is prohibited.

[Note: Further information regarding discrimination can be found in District Board of Trustees (DBOT) Rule 3.27: Discrimination, Harassment, and Sexual Harassment and Polk State College Procedure 6091: Discrimination, Harassment, and Sexual Misconduct.]

## E. Dishonesty

Regardless of intent, dishonesty includes:

- 1. Engaging in cheating, plagiarism, or academic dishonesty as defined in Polk State College Procedure 5026: *Academic Dishonesty Procedure* or Section VIII of this document.
- 2. Intentionally initiating (or causing to be initiated) any false report, warning, or threat of fire, explosion, or other emergency on the College's property or at a College-sponsored activity.
- 3. Falsely contracting on behalf of (or representing oneself in the name of) Polk State College.
- 4. Furnishing false information to any faculty member, College official, or College office.
- 5. Forgery, alteration, or misuse of any College document, record, or instrument of identification. This includes, but is not limited to, the submission of false or fictitious claims, or any entries or omissions of information, for the purpose of misleading or misrepresenting a student's record or any other official document.
- 6. Tampering with the election of a recognized student organization.
- 7. Violation of copyright.

## F. Disorderly Conduct

Disorderly, lewd, or indecent conduct is prohibited on Polk State College's premises, at sponsored activities, or at College-related functions. This includes actions and conduct that breach the peace or involve aiding, abetting, or procuring another person to breach the peace.

## G. Disruption or Misbehavior

The disruption or obstruction of teaching, research, administration, disciplinary proceedings, and other Polk State College activities (including its functions on or off campus) is prohibited. This includes classroom disturbances, physical or verbal altercations, animals on campus (except for service animals), or bringing a child, visitor, or other unregistered student to a course meeting.

## H. False Reporting

This includes knowingly and falsely reporting a bomb, an active shooter, or another dangerous situation to any College office or personnel.

[Note: The College fully cooperates with local, state, and federal authorities to identify students

# who make such reports.]

## I. Fraud

"Fraud" is defined as deceit, trickery, or a breach of confidence that is perpetrated for profit or to gain some unfair or dishonest advantage (e.g., willful negligence intended to cause damage to the material interest of the College; or dishonorable, irresponsible, or deliberate acts against the College, its faculty and staff, its students, or its representatives).

#### J. Gambling

The College prohibits the stake or risk of money (or anything of value) on the outcome of something involving chance that is related to College operations or activities, regardless of whether the event or activity occurs on or off campus.

## K. Grade or Enrollment Falsification Requests

This includes asking a professor or any College official to make a change to a valid course or assignment grade, or to the student's enrollment status, to address the student's status in various activities and programs, including, but not limited to, immigration status, financial aid eligibility or awards, intercollegiate participation, Honors Program participation, conditions for employment, or other opportunities which have grade or enrollment requirements.

#### L. Hazing

Florida Statute Section 1006.63 describes "hazing" as any action or situation which recklessly or intentionally endangers the mental or physical health or safety of a student for the purpose of initiation, admission into, or affiliation with any organization operating under the sanction of Polk State College. Examples of hazing include, but are not limited to, pressuring or coercing the student into violating state or federal law; any brutality of a physical nature such as whipping, beating, branding, or exposure to the elements; forced consumption of any food, liquor, drug, or other substance; or other activity causing extreme mental stress such as sleep deprivation.

Further examples of hazing are found in *Florida Statute Section 1006.63*. Any student or person associated with a Polk State College organization is prohibited from engaging in any hazing activity.

[Note: Hazing does not include customary athletic events (or similar contests), competitions, activities, or conduct that furthers a legal and legitimate objective.]

## M. Infringement on Freedom of Expression

Intentionally or substantially interfering with the freedom of expression of others on any College property or at any College-sponsored activity is prohibited.

## N. Misuse of Keys

Unauthorized possession, duplication, or use of keys for any of the College's premises is prohibited. This includes any unauthorized entry to, or use of, College premises, facilities, equipment, or supplies.

#### O. Misuse of Student Media

The misuse of student media is prohibited (e.g., publications or budgets for student publications). Misuse of media applies to all unauthorized use of student media as outlined in Polk State College Procedure 5021: *Student Media*.

## P. Non-Compliance with Directions

Failure to comply with directions or directives provided by any Polk State College official, instructor, security officer, or law enforcement officer who is acting in the performance of his or her duties is prohibited. This includes failure to identify oneself to these persons when requested to do so.

## Q. Non-Compliance with the Student Discipline System

Any abuse of the student discipline system is prohibited, including, but not limited to:

- 1. Failure to appear before any Polk State College official when requested to do so.
- 2. Falsification, distortion, or misrepresentation of information placed before a Student Conduct, Petitions, or Disciplinary Committee Hearing.
- 3. Disruption or interference with the orderly conduct of a Disciplinary Committee Hearing.
- 4. False accusation of student misconduct without cause.
- 5. Any attempt to discourage an individual's proper participation in, or use of, the student discipline system.
- 6. Harassment (i.e., verbal or physical) or intimidation of a member of a Student Disciplinary Committee prior to, during, or after a Disciplinary Committee Hearing.
- 7. Failure to comply with the sanction(s) imposed under the Student Code of Conduct.
- 8. Coercion or attempting to influence another person to commit an abuse of the student discipline system.

#### R. Obstruction of Movement

Obstruction of the free flow of pedestrian or vehicular traffic on any Polk State College property, or at a College-sponsored or College-supervised function, is prohibited.

#### S. Possession or Use of Alcohol

Use, possession of, or distribution of alcohol beverages on or off campus or at any College event (i.e., regardless of the age of the student) is prohibited.

#### T. Possession or Use of Controlled Substances

Unauthorized distribution, or possession (or possession for the purposes of distribution) of any controlled substance or illegal drug on a Polk State College property or at a College-sponsored activity (i.e., on or off campus) is prohibited.

## U. Possession or Use of Weapons and Dangerous Materials

Illegal or unauthorized use, possession, or storage of any weapon (e.g., firearm, explosive, dangerous chemical) on a Polk State College property or at a College-sponsored activity is prohibited.

#### V. Public Intoxication

Inebriation or drunkenness while on a Polk State College campus or at an on- or off-campus event is prohibited. This includes becoming intoxicated while on campus or at an off-campus activity or class.

# W. Theft or Abuse of Computer Time

The College prohibits any theft or abuse of computer time including, but not limited to:

- 1. Unauthorized entry into a file to use, read, or change the contents of the file, or for any other purpose.
- 2. Unauthorized file transference.
- 3. Unauthorized use of another individual's identification and password.
- 4. Use of computing facilities to interfere with the work of another student, faculty member, or College official.
- 5. Use of computing facilities to send obscene or abusive messages.
- 6. Use of computing facilities to interfere with the normal operation of the College's computing system.
- Misuse of institutional e-mail, such as engaging in chain letters, forgery, email harassment, or other misuses as defined in Polk State College Procedure 1030: College Student E-mail System.

# X. Theft or Damage to Property

Attempted (or actual) theft of (or damage to) the property of other students, the College, College officials, or College guests is prohibited. This also encompasses possession of stolen property on any of the College's premises or at a College activity.

#### Y. Unauthorized Demonstration

Individuals are prohibited from participating in any campus demonstration that disrupts the normal operations of Polk State College or infringes on the rights of other members of the Polk State College community. This includes leading or inciting others to disrupt scheduled or normal activities within any campus building or area, or any intentional obstruction that unreasonably interferes with freedom of movement on campus (e.g., pedestrian or vehicular movement).

## Z. Unauthorized Recording

A student may not make an audio or video recording of a Polk State College instructor, official, or speaker at a College event or activity (i.e., at an on- or off-campus event) unless prior consent of the instructor or speaker is obtained. Additionally, a student is not permitted to video or audio record the activities of another student without his or her express permission. A student may record video or audio of class lectures for his or her own personal educational use, in connection with a complaint to the public institution of higher education where the recording was made, or as evidence in, or in preparation for, a criminal or civil proceeding. A recorded lecture may not be published without the consent of the lecturer.

[Note: For a recording made as a necessary accommodation related to the Americans with Disabilities Act, prior notification of the instructor or speaker is also required.]

# VI. Violation of College Policies and Procedures

The College has established and published *District Board of Trustees Rules* and *Polk State College Procedures* detailing College governance, processes, and policies. Violation of any of these Rules or Procedures is prohibited. An individual is expected to be informed regarding policies and procedures; ignorance does not mitigate responsibility for violating conduct expectations.

#### VII. Violation of Law

Any violation of federal, state, or local law on any of Polk State College's premises, or while attending any College-sponsored or College-supervised activity, is prohibited:

- A. If a student is charged only with an off-campus violation of federal, state, or local law, but not with any other violation of the *Polk State College Student Code of Conduct*, disciplinary action may be taken, and sanctions imposed for grave misconduct that demonstrates flagrant disregard for the Polk State College community or disrupts the educational mission of the College.
- B. Polk State College disciplinary proceedings may be instituted against a student charged with a violation of a law if he or she is also in violation of the *Student Code of Conduct*. College proceedings may be carried out prior to, simultaneously with, or following civil or criminal proceedings off campus.
- C. When a student is charged by federal, state, or local authorities with a violation of law, Polk State College does not request or agree to special consideration for that individual because of his or her status as a student; however, if the alleged offense is also the subject of a proceeding before the Discipline Committee under the *Student Code of Conduct*, Polk State College may advise off-campus authorities of the existence of the *Student Code of Conduct* and of how such matters are handled within the Polk State College community.

D. Polk State College cooperates fully with law enforcement and other agencies in criminal law enforcement on campus, as well as regarding conditions imposed by criminal courts for the rehabilitation of student visitors. Individual students and faculty members acting in their personal capacities remain free to interact with governmental representatives as they deem appropriate.

# VIII. Academic Dishonesty

Polk State College considers academic dishonesty an assault upon the basic integrity and meaning of a College education. Cheating, plagiarism, and collusion in dishonest activities are serious acts which erode the College's educational role and cheapen the learning experience, not only for the perpetrators, but also for the entire community. Each Polk State College student is expected to understand and subscribe to the ideals of academic integrity, as well as bear individual responsibility for his or her own work. Materials (written or otherwise) submitted to fulfill academic requirements must represent a student's own efforts. The fundamental purpose of this rule is to emphasize that any act of academic dishonesty attempted by a Polk State College student is unacceptable and is not tolerated.

Any violation of the College's policies pertaining to academic dishonesty may result in academic penalties and disciplinary action at the discretion of the instructor. Academic penalties may include (but are not limited to) a failing grade for a particular assignment or a failing grade in the particular course. A student who is charged with violating the Academic Dishonesty portion of this Rule is not permitted to withdraw from the course. Additionally, the student may be referred to an Academic or Student Services Dean for disciplinary action. Any student who is suspected of violating the Academic Dishonesty section of the *Student Code of Conduct* is subject to sanctions and provided due process as outlined in Polk State College Procedure 5026: *Academic Dishonesty Procedure*.

Examples of academic dishonesty include, but are not limited to:

A. Cheating or Plagiarizing on Tests, Projects, Papers, or Assignments "Cheating" is defined as the giving or taking of any information or material with the intent of wrongfully aiding oneself or another in academic work considered in the determination of a course grade.

"Plagiarism" is defined as "the act of appropriating the literary composition of another, or parts or passages of writings, or the ideas or language of the same, and passing them off as the product of one's own mind" (*Black's Law Dictionary*, Revised Fourth Edition). Plagiarism includes failure to use quotation marks or other conventional markings around material quoted from any printed source, paraphrasing a specific passage from a specific source, or any use of material obtained from a source without indicating accurately what that source is. Plagiarism further includes letting another person compose or rewrite a student's assignment.

Polk State College Procedure 5026: *Academic Dishonesty Procedure* addresses the protocols by which academic dishonesty cases are processed and appealed.

The following items have been identified by Polk State faculty and students as examples of cheating and plagiarism. This list is not meant to be all inclusive:

- 1. Asking for information from another student before, during, or after a test, quiz, or exam situation.
- 2. Copying answers from another's paper during a test, quiz, or exam situation.
- 3. Knowingly letting someone copy from one's paper during a test, quiz, or exam situation.
- 4. Using sources, tools, or resources other than what is permitted by the instructor in a test, quiz. or exam situation.
- 5. Copying material exactly, partially, or essentially from outside sources while omitting appropriate documentation.

- 6. Copying or falsifying a report of a laboratory, clinical project, or assignment without doing the required work.
- 7. Changing answers on a returned-graded test, quiz, or exam for the purpose of having the grade revised.
- 8. Use of a language processing tool (e.g., ChatGPT, Jasper Chat, Open AI), or any other Artificial Intelligence-driven application, to provide responses, text, or materials for a course and presenting these products as original work.

In addition to the above definition, plagiarism includes purchasing a document from a term paper service or procuring any portion of a paper from the Internet, and then handing in and presenting another person's academic work as one's own.

[Note: Individual academic departments may provide additional examples in writing of what does and does not constitute plagiarism, provided that such examples do not conflict with the intent of this policy.]

- B. Furnishing False Information to Any Faculty Member
  The policies regarding academic integrity broadly apply to any information requested, including, but not limited to, attendance, participation, course work, personal conduct, or the conduct of others.
- C. Forgery, Alteration, or Misuse of Any College Document, Record, or Instrument of Identification This includes, but is not limited to, submission of false information, manipulation of information, or omission of information, for the purpose of misrepresenting a student's identity, academic record, or any other official document.

# IX. Student Organizations and Violations of the Student Code of Conduct

- A. Student organizations are governed by the *Polk State College Student Organization Handbook*, which outlines the procedures to be used for organizing, chartering, and maintaining student organizations at the College. The Handbook is located in the Student Activities and Leadership Office (SALO) on each campus. Students are expected to follow the Handbook as it relates to their organizations and to the *Student Code of Conduct*. Student organizations (as well as members and officers, individually and collectively) may be held accountable when an alleged offense is committed by one or more members or guests of the organization, and when any of the following conditions apply:
  - 1. The offense occurs at an event that was sanctioned by an officer of the organization.
  - 2. Organizational funds are used to finance the activity.
  - 3. The event where the offense occurs is substantially supported by the organization's membership.
  - 4. Members with knowledge of a forthcoming violation do not attempt to prevent the infraction.
  - 5. The organization fails to report or chooses to protect the individual(s) alleged to have committed the offense.
- B. Any student organization (as well as members and officers, individually and collectively) that is suspected of violating the *Student Organization Code of Conduct* portion of this Rule is subject to sanctions and provided due process as outlined in Polk State College Procedure 5029: *Student Code of Conduct Violation Procedure: Student Groups and Organizations.*

#### X. Sexual Misconduct

Polk State College Procedure 6091: *Discrimination, Harassment, and Sexual Misconduct* outlines the definition of sexual misconduct and the sanctions the College imposes on offenders. Typical types of sexual misconduct include, but are not limited to, the following:

#### A. Sexual Harassment

Sexual harassment includes any unwelcome conduct that a reasonable person would find so severe, pervasive, and objectively offensive that it denies a person equal educational access, or creates an intimidating, hostile, or offensive work or study environment. Sexual harassment includes reports of stalking, domestic violence, and dating violence.

[Note: A report of sexual assault, dating violence, domestic violence, or stalking does not need to meet the description of "severe and pervasive."]

B. Sexual Battery

Sexual battery includes any act, or attempted act, as defined in *Florida Statute Section 794.011*.

## C. Public Indecency

This includes exposing one's body in such a manner that another party reasonably could be offended, or any sexual conduct where another party reasonably could be offended.

# XI. Provisions Pertaining to Institute of Public Safety Students

In addition to the *Student Code of Conduct*, any Institute of Public Safety student who is enrolled in a program or course regulated by the Florida Criminal Justice Standards and Training Commission is subject to the provisions of the Institute's *Trainee Rules, Regulations, and Procedures* booklet.
