

Associate and Bachelor Degree Coursework

A fingerprint background check and the resulting security clearance ID badge are **REQUIRED** before your first day on the campus of any school (Pre-kindergarten – Grade 12 or early learning center) in Polk County, FL, for course related field experience or internship.

AA and AS students

A copy of your valid Polk County School Board photo ID badge must be received by Polk State College to complete Field Experiences as required for a passing grade in the following courses:

- EDF 1005 Introduction to the Teaching Profession
- EDF 2085 Introduction to Diversity for Educators

Prospective BS in Education students

A copy of your valid Polk County School Board photo ID badge must be received by the program director within three weeks after the start of Polk State College upper division teacher education courses in order to continue in a BS in Education degree program.

- 4. Exact payment (**Money Order ONLY**) as delineated on the School Board form included in this document

<u>PLEASE NOTE</u>: Please do not call the Polk County School District Fingerprinting Services regarding your photo ID badge. After your background clearance is completed, the District will send your photo ID to Polk State College. You must check your Polk State College email address (not PAL email) for detailed directions for ID badge pickup options from Star Anderson.  Department of Ed. Only valid in Polk County.
- I will need my fingerprints retained for two years. (\$55.25) Only valid in Polk County.
 I will need my fingerprints retained for three years. (\$61.25) Only valid in Polk County.
 I will need my prints to be valid for five years. (\$78.60) Prints will be valid in any County in the State of Florida.
