Students who have been accepted into the Professional Pilot Science AS Program are eligible for increased cost of attendance budgets. The cost of attendance budget is Polk State College's minimum estimate of how much money the flight degree will cost you to achieve. In accordance with federal regulations, it is used to determine the amount of Title IV and/or VA financial aid for which you are eligible. Generally, the higher your budget the more aid you will be eligible for (however, there are limits and exceptions to this rule). To be eligible for this increase, you must meet the following two requirements:

- Must be seeking Professional Pilot degree
- Must maintain Satisfactory Academic Progress

The budget increase is valid only if you are enrolled in the below listed courses. This information will be used to substantiate the additional costs of flight labs/training.

NOTE: The costs listed below represent the minimum cost of training. Additional training may be needed. If additional training is required, the additional training costs will be the financial responsibility of the student.
