It may be posted in an HTML webpage format or as a link to a PDF. Notes:

Replacing lost revenue from academic sources includes two sources. One is from student debt in the amount of \$1,307,968. For any student that was enrolled on or after March 13, 2020, that had a balance in their account, the entire balance was cleared. The other is from lost tuition due to reduced enrollment in the amount of \$1,632,380 in which \$780,258 was allocated to (a)(2) funds and \$852,122 was allocated to (a)(1). This closes out the (a)(1) funds as they are now exhausted.

Replacing lost revenue from auxiliary services sources totals \$277,968. (Use of facilities, ticket sales, summer camp programs, and coin copier sales).

Both lost revenue categories for tuition and fees encompass the timeframe between March 13, 2020, to June 30, 2021, and a three-year average was used as a base comparison.

Other Uses of (a)(1) Institutional Portion funds includes \$1,500,000 in indirect costs recovered, \$2,349,777 in compensation for the repurposing of staff and overtime for hours additional work created, \$28,583 in costs for accountant solely dedicated to HEERF grant implementation and support, and \$17 for a miscellaneous item. The difference of \$930 was a reduction to correct previously reported items that had to be adjusted out of the HEERF grant account.

Other Uses of (a)(2) or (a)(3) funds, if applicable \$1,452 cost for consultant services dedicated to grant activities.
