Polk State College District Board of Trustees Considering Changes in Fees for 2018/19

Winter Haven, April 11, 2018 - The Polk State College District Board of Trustees (DBOT) will consider changes in lab fees for college credit and Educator Preparation Institute courses offered at the College at the May 21,2018 Board Meeting. Each year the College evaluates all fees to ensure that charges accurately reflect any changes in the cost of instructional materials or supplemental items required for courses. For the 2018/2019 academic year, 42 lab fees are decreasing and 5 fees are being added to serve new courses. Details of the fee changes are described below:
