Description: This course is designed with the goal to better prepare the criminal justice officer to recognize and respond to a variety of critical incidents. Topics of instruction include: Physical well-being, responding to emergency situations, civil and inmate disorder procedures, specialized task units, special crimes, and practical exercises. Additional topics relative to local agency needs may be covered to include tactical response to an ambush, tactical incidents involving mass transit, environmental disasters, crowd control plan, emergency first aid, bombs and booby traps, special search procedures, psychological factor encounters, emergency evacuation encounters, officer observation and safety, and terrorism awareness and operations.

This course qualifies for **salary incentive** or **mandatory** retraining.
