the next 10 years, how you will accomplish it, and what the continuing impact of those accomplishment be after you are gone.

Submissions will be evaluated based on thoughtfulness, as evidenced by the originality of your goals, th level of consideration given to how you will accomplish them, and how realistic they appear to be. Don't assume that a general desire to save the world or cure cancer is more impressive than a plan to provide certain family member if the plan to provide for the family member has clearly been carefully thought through and can realistically be achieved.

There is no minimum or maximum length requirement, but we expect that the winning essay will fall somewhere between 750 and 1,500 words.

Scholarship Award: \$1,000

The Legacy Planning Scholarship will be awarded to a student based on his or her application

Deadline:

- All Applications must be received by email on or before November 29th, 2015.
- The Scholarship winners essay will be posted on the website and the winner will be notified via email
